Child Safeguarding Statement

The LWSSL in accordance with the FAI Rulebook, FAI Child Welfare and Safeguarding policy, other FAI policies, procedures and our legislative requirements have agreed this Child Safeguarding Statement which is binding on all members. The LWSSL is a Soccer League operating on a local scale providing sporting activities and opportunities for children and young people through participation in the league Interleague Squads and affiliated Clubs. The League offers sporting activities to children and young people from the age of 14. The League recruits approximately ten volunteers with over 50 participants. The League is committed to safeguarding children and by working under the guidance of our Safeguarding Policies and procedures, our volunteers working with our children and young people, seek to create a safe and fun environment for children and young people to participate in their sport.

Principles to Safeguard Children from Harm

This statement recognises that in accordance with legislation and the requirements of the FAI Handbook, FAI Child Welfare and Safeguarding policy, other FAI policies and procedures that the welfare and interests of children are paramount in all circumstances. The LWSSL is established on a number of core principles:

- the needs of the Child, integrity and respect, environment, equality, fair play, welfare and safety in football. These underlying principles underpin our rules, policies and procedures to ensure that when Children participating in our activities, they do so, as far as is practicable, in a safe and enjoyable environment.

Risk Assessment

In preparing this statement the LWSSL have completed a Risk Assessment of the potential risk of harm to children when they are participating in any of our games and attending our activities. The risks were reviewed under the following headings; League and Coaching Practices; Complaints & Discipline; Reporting Procedures; Use of Facilities; Recruitment; Communications; and General Risk of Harm. The Risk Assessment was undertaken on 23rd April 2018. The table below lists the area of Risk identified and the list of procedures and policies for managing these risks
